1. We have reviewed your response to prior comment 2. Please confirm to us that your compensation discussion and analysis in future filings will be sufficiently clear so that investors can see how the amounts of the incentive cash bonuses awarded to each named executive officer were determined.

We urge all persons who are responsible for the accuracy and adequacy of the disclosure in the filing to be certain that the filing includes the information the Securities Exchange Act of 1934 and all applicable Exchange Act rules require. Since the company and its management are in possession of all facts relating to a company's disclosure, they are responsible for the accuracy and adequacy of the disclosures they have made.
